PLANS REQUIRED WITH THIS APPLICATION, including but not limited to:

- * **2 PLOT PLANS** - stamped approved by the Utility Company
- * **SITE PLAN** – showing individual square foot measurements of all impervious surfaces.
Ex: House footprint, pool, pool deck, accessory buildings, parking, driveway, etc....
- * **2 POOL PLANS** - no decking or equipment in easements of any kind
- * **2 DRAINAGE PLANS** - showing natural flow prior to construction.

If any portion of construction, including decking, is within ten feet (10') of the property line, a licensed professional engineer is required to design the grading plan for the project. Additional inspection will be required.

PLEASE ALLOW A MINIMUM OF 10 WORKING DAYS FOR REVIEW

THE PERMIT IS ISSUED BASED ON, BUT NOT LIMITED TO:

- **PACKET SHALL BE ONSITE AND VISIBLE**
- Minimum 4' barrier around pool
- Gaps in/under fence/gates shall not exceed 4"
- Landscape / Drainage runoff shall be addressed if necessary
- Site must be secured by safety fencing during construction
- No pool structure, decking or equipment shall encroach easements
- 22' setback required from water's edge to overhead power lines
- Additional inspections may be required at inspector's discretion
- Junction boxes/transformers cannot be located less than 5' from interior pool wall
- All gates shall be self closing & self latching
- Solar cover required for heated portion
- Backwash shall drain to sanitary sewer
- Sidewalks/streets shall be kept clean
- Metal assembly within 5' of pool shall be bonded
- Accessible electrical outlets must be on GFCI
- Drains shall be designed and installed in accordance with ANSI/APSP-7
- Minimum 5' setback from foundation to water's edge unless letter of approval provided by Professional Engineer
