 - 1. PUBLIC HEARING: consider an application requesting a variance to Article 8.03 (C) 4 (b) (2), Single Family-Residential District- (36,000 sq. ft. Minimum), Unified Development Code. The applicant is seeking a variance to encroach into the side

setback for the main house, being (1.5') west of the property line for the front of the main house, and (1.4') west of the property line for the rear of the main house. In addition, an accessory building, specifically; a carport located on the front of the main house, being (3.6') west of the property line for the front of the carport, and (3.3') west of the property line for the rear of the carport, and an additional accessory building north of the main house, being (9.5') west of the property line for the front of the accessory building and (9.8') west of the property line for the rear of the accessory building. For the purpose of; accommodating of an existing structure in non-compliance at the time of annexation (Ordinance 360, August 30, 1983) and to allow future development on the property and/or facilitate future sale of the property, and to document legality. The request is for Lot 1, Block A, Isaac Addition, 1907 Florence Road. Owner/Applicant: Billy Isaac. (ZBA-18-0003).
